The establishment of Medicare and the creation of a universal health system is regarded as one of Australia's key public policy successes and a true foundation stone of the prosperity Australians enjoy.

This year marks the 40th Anniversary of Medicare, celebrating four decades of ensuring access to healthcare for all Australians. While many political names are associated with this innovation, it is widely acknowledged that it was the work of Professor John Deeble, often referred to as 'the father of Medicare,' that led to the establishment of first Medibank and subsequently Medicare.

John passed away in October 2018, and with the support of his family, we have established a lecture in his name.

The Lecture sees a distinguished leader in health policy development engage an audience of public sector leaders and executives, health executives, and academics regarding key issues of national health policy importance. Reflecting on the journey to date, attendees will also examine the vision to come.

John Deeble made an indelible mark on the Australian healthcare system and left us with an enduring legacy.

# PROFESSOR JONATHON GRAY



# Honorary Professor, School of Medicine, Cardiff University Member Centre for Healthcare Innovation, Leadership Council, Singapore

Jonathon is a passionate leader of large scale change, and brings over thirty years of experience as a medical doctor, academic, CEO, executive team member, and as a director of local, national and international improvement and innovation.

Jonathon designed and co-led the 1000 lives Campaign in Wales; established and led an Innovation Institute in New Zealand delivering the 20,000 days Campaign and more than 10 improvement collaboratives. Jonathon was the founding Director of the Asia Pacific Innovation Conferences (APAC) that brought together thousands of passionate colleagues annually. Jonathon and colleagues supported Dr Michael Dixon's inspirational work, building a 'pop-up' Institute for Social Prescribing in England.

Jonathon is very proud to have spent time as an Ambassador for the Hillary Institute and the

co-creator of the Centre for Health Leadership, Innovation, Management and Beliefs (CLIMB).

Most notably, in 2020 during the Covid-19 pandemic, Jonathon led the design and build of the 'surge hospital' for Cardiff, a 2000 bed hospital, built in 6 weeks, in the national rugby stadium. As a result of seeing young leaders 'running towards the fire' in 2022 Jonathon established 'Climb', a Welsh future leaders programme, and developed close links to similar programs in Singapore and London.

In 2024, with the support of King Charles III, Jonathon brought together a group of emerging and experienced leaders from across the Commonwealth countries to launch the Commonwealth Leadership Institute.





# **PROFESSOR MICHAEL PERVAN**

Michael has represented Western Australia and Tasmania at the Australian Health Ministers Advisory Council, of which he was elected Chair in 2018. Michael was awarded a Churchill Fellowship in 1998 and the insights and global network that opportunity provided him can be seen in his consistent contributions to national reform discussions for over 20 years on issues such as service system reform, health workforce and mental health.

Professor Michael Pervan C.F. was appointed as Chief Executive Officer of the Australian Independent Health and Aged Care Pricing Authority (IHACPA) on 1 February 2023. Prior to this, Michael was Secretary of the Department of Health and Human Services and the Department of Communities Tasmania where for nearly a decade he was responsible for the delivery of health, housing and care services as well as designing and implementing major service reforms.

Michael's perspective on strategic and policy issues is informed by considerable operational experience at service and system level where he has led financial governance initiatives, and implemented reform programs across health, human services, child development services, chronic disease management, child protection, out of home care, youth justice and ambulance services in Western Australia and Tasmania.





# RADM SONYA BENNETT AM


# Commander Joint Health and Surgeon General Australian Defence Force

Commander Joint Health and Surgeon General Australian Defence Force Rear Admiral (RADM) Bennett commenced as Commander Joint Health (CJHLTH) and Surgeon General Australian Defence Force (SGADF) on 1 December 2023. RADM Bennett is a practicing Public Health Physician and is a Fellow of the Royal Australian College of General Practitioners and the Australasian Faculty of Public Health Medicine. RADM Bennett is a current member of the Queensland Institute of Medical Research (QIMR) Berghofer Council.

RADM Bennett was previously Deputy Chief Medical Officer in the Commonwealth Department of Health and Aged Care and Director General Navy Health Reserves. In addition RADM Bennett has previously worked in Queensland Health as Deputy Health Officer, a member of the Australian Technical Advisory Group on Immunisation, (ATAGI), Chair of the Communicable Disease Network of Australia (CDNA), and member of the Australian Health Protection Principle Committee (AHPPC).

As a medical officer in the Australian Defence Force, RADM Bennett served full-time with the Royal Australian Navy from 1994 to 2009. Postings during this period include HMAS



PLATYPUS as Submarine Squadron Medical Officer, Deputy Medical Officer in Charge at Balmoral Naval Hospital, sea postings on HMAS SUCCESS, the Army Malaria Institute and Centre for Military and Veterans Health as the Research Manager/Chief of Operations.

Following transition to the part-time force in 2009, RADM Bennett has deployed to Pacific Partnership 2015 on the USNS Mercy as a public health physician as well as continuing in the RAN as a member of the Independent Seaworthiness Management Review panel. RADM Bennett's broad technical expertise and leadership in public health was recognised in the 2023 Australia Day awards where she was appointed as a Member of the Order of Australia (AM) General Division.

health expert and Adjunct Professor in
the Faculty of Medicine at the University
of New South Wales and Honorary
Professor in the College of Health and
Medicine at the Australian National
University.

Lucas leads a dedicated team that manage Australia's regional and global investments in health, including the new \$620 million Partnerships for a Healthy Region initiative.

Prior to joining DFAT, Lucas led Australia's National COVID-19 Vaccine Program at the Department of Health and Aged Care, and was heavily involved in many aspects of Australia's COVID-19 response, including the Primary Care and First Nations responses as well as the response in multicultural and rural communities.

Lucas has a wealth of health sector experience, including previously serving as Chief Health Officer at Miwatj Health, the regional Aboriginal communitycontrolled health service for East



Arnhem Land in the Northern Territory, and was a member of the Northern Territory Clinical Senate, and a board member of the Northern Territory Aids and Hepatitis Council. He has also held academic positions at the University of Melbourne, University of Sydney, Flinders University and Harvard University.

Lucas undertook his medical training at the Universidad Autónoma de Madrid, Spain, with placements at the University of Sydney. He completed further postgraduate training at Harvard University, focusing on health systems and leadership in health and human rights.

Andrew Denton is an award-winning writer, performer and producer. His TV programs include The Money or the Gun, Enough Rope, CNNNN (The Chaser), and The Gruen Transfer.

In 1997, Andrew witnessed the painful death of his father Kit. Determined to help others avoid this suffering, he campaigned to introduce compassionate laws for voluntary assisted dying. His two, ground-breaking podcast series, Better Off Dead, (2015 & 2021) helped to both inform, and inflame, this debate.

He formed the organisation Go Gentle Australia in 2016 to help Australians with untreatable or terminal illnesses, as well as their families and carers.

In tandem with state-based organisations, Andrew has led successful advocacy campaigns to introduce VAD laws in Victoria (2017), Western Australia (2019), Tasmania, South Australia and Queensland (2021), and NSW (2022)

Dr Alicia Veasey, a proud Torres Strait Islander woman, is an Obstetrician & Gynaecologist with a subspeciality fellowship in Paediatric & Adolescent Gynaecology working on Bundjalung Country with Northern New South Wales LHD.

She also holds a senior leadership position within Queensland Health as Co-Chair of the Queensland Aboriginal and Torres Strait Islander Clinical Network, where she provides leadership on systemic cultural safety and strengths-based approaches to health system reform that centres Aboriginal and Torres Strait Islander people's sovereignty and right to self-determination.

# Obstetrician and Gynaecologist Northern NSW Local Health District

Recognising early on in her medical career the need for health system reform to address the racism and inequity in health care, Alicia completed a Master of Public Health and a Master of Health Management. In 2023, Alicia was awarded a Fellowship with the prestigious Atlantic Fellows for Social Equity, where she completed a Master of (Indigenous) Social Change Leadership, culminating in a dissertation exploring opportunities to embed Indigenous self-determination and sovereignty within the acute care health systems.

Alicia is an experienced and sought after health leader, providing input into local, state and national health policy, A strategies and reform agendas, as well as being a senior advisor to media, research projects and nongovernment organisations.

She is currently a non-executive Director for the Australian Commission for Safety & Quality in Health Care, and Advisory Board member for the Australian Health Review journal. She has previously served as a non-executive Director for the Australian Indigenous Doctors' Association, a founding member of Health Workforce Australis Future Health Leaders Council and was a delegate with the National Congress of Australia's First Peoples.

Dr. Mataroria Lyndon descends from the Ngāti Hine, Ngāti Whātua, Ngāti Wai, and Waikato iwi, indigenous tribes of Aotearoa New Zealand. As a Māori clinician, academic, and governance leader, Dr. Lyndon's influence spans health and academia.

In his governance roles, he has served as the Deputy Chair of the Health Promotion Agency and as a board member of the Māori Health Authority and the Northland District Health Board. Currently, he is a board member of Pūtahi Manawa Centre of Research Excellence for Heart Health and the Fisher & Paykel Healthcare Foundation.

Mataroria completed his Master of Public Health at Harvard University as a Fulbright Scholar and his PhD is focused on medical education. He was also awarded the Deloitte IPANZ Young Professional of the Year.

Mataroria is the co-founder of Tend Health, which has become one of the largest primary healthcare providers in New Zealand. He also serves as a Senior Lecturer in Medical Education at the University of Auckland. He was previously the Equity Lead at Mahitahi Hauora Primary Health Organisation, a Clinical Lead at Ko Awatea – Centre for Innovation and Improvement, and a medical lead for Māori Health at Counties Manukau District Health Board.

Prof. Abbey holds postgraduate degrees in
Physics, Nanotechnology, and Engineering
from UCL, Imperial College London, and the
University of Oxford, respectively. He earned
his PhD in Chemistry from Cambridge
University in 2007.

For over 16 years, Prof. Abbey has led the development of pioneering technologies in optical biosensing. His research has been recognized with several national prizes and awards for research excellence and innovation. In 2019, he received the national Medtech's Got Talent award for co-inventing a novel photonics-based diagnostic test for early-stage breast cancer. More recently, he was honoured with both the 2022 Eureka Prize for innovative use of technology and the 2022 Victoria Prize for Science and Innovation.

#### Professor John Deeble AO (9 July 1931- 5 October 2018)

Together with Doctor Dick Scotton, Professor John Deeble coauthored the original proposals for universal health insurance in Australia in 1968 while working at the Melbourne University Institute of Applied Economic Research. These proposals led to the 1975 establishment of Medibank, and subsequently, Medicare, in 1984.

John was Special Adviser to the Ministers for health in the Whitlam and Hawke governments, Chairman of the Planning Committees for both Medibank and Medicare and a Commissioner of the Health Insurance Commission for 16 years. Other appointments have included First Assistant Secretary in the Commonwealth Department of Health, Founding Director of the Australian Institute of Health and Welfare, and from 1989 to 2005, Senior Fellow in Epidemiology and Adjunct Professor in Economics at the National Centre for Epidemiology and Population Health at the Australian National University.

Professor Deeble was a World Bank Consultant on health care financing in Hungary, Turkey, and Indonesia, and for over 10 years an adviser to the government of South Africa.

John was a Sidney Sax Medallist and life member of the Australian Healthcare and Hospitals Association, and patron of the Deeble Institute for Health Policy Research.
